An exceptionally durable stain for use on decking, siding, fencing, composite boards, outdoor furniture, steps, railings, concrete patios, and walkways. The finish is water repellent and fade resistant. Solid color stains provide excellent adhesion to new, previously stained or painted surfaces, which are in clean, sound condition.

SURFACE PREPARATION:

In order to be effective a stain must be able to adhere to the surface. Surfaces must be sound, and absolutely dry. Be sure the surface is free of all dirt, mildew stains, loose wood fibers, and other foreign matter. Old loose surface coatings should be scraped off and edges sanded smooth for proper adhesion. Prior to staining, the entire area should be properly cleaned with Penofin **Pro-Tech Cleaner #2**.

APPLICATION:

Apply with nylon or polyester brush, stain pads or professional spray equipment. When spraying always back-brush immediately. Do not over apply. Shake and stir thoroughly before and during use. If the project requires more than 1 container, blend all containers together to ensure uniformity. Apply to small sections at a time (1-3 boards); to avoid lap marks. Requires 2-coat application.

CLEAN UP:

Clean brushes and equipment with soap and water. Dispose of empty cans or unused portion in accordance with local, state, and federal regulations.

CAUTION! KEEP OUT OF THE REACH OF CHILDREN. My cause eye and skin irritation. Use only with adequate ventilation. Avoid breathing vapors, spray mist, or standing dust.
